Please note: 1) This balance transfer form must be completed accurate and legibly. 2) Please be advised not to transfer the amount of any disputed purchase or other charge, as you may lose your rights to dispute that purchase or charge. 3) The balance transfer request will be processed within 2-3 business days of receipt by Nordstrom Federal Credit Union. Please continue to make the minimum payment of the designated credit card account until that credit card issuer notifies you that the balance has been transferred. Payment of the amount authorized by you may or may not pay off the outstanding balance on the other credit card account. Nordstrom Federal Credit Union is not responsible for any remaining balance, finance charge, or other charge (resulting from the balance transfer or any missed payments) on the other credit card account.
